1. Aristotle University of Thessaloniki:

Courses at Aristotle University of Thessaloniki are normally taught in Greek. 2. Universidade Nova de Lisboa

The Course of Portuguese Language and Culture is offered all year at FCSH/UNL. Attendance is mandatory and at no cost for all incoming students of FCSH/UNL.

Students have to attend at least one subject per semester, among the other courses (max. 36 ECTS credits per semester), in the Department of Musical Sciences.

The stay' period of students can only be testified according to our academic calendar: 4 or 5 months for one semester and 9 months for full academic year.

4. Termination of the agreement

In the event of unilateral termination, a notice of at least one academic year should be given. This means that a unilateral decision to discontinue the exchanges notified to the other party by 1 September 20XX will only take effect as of 1 September 20XX+1. The termination clauses must include the following disclaimer: "Neither the European Commission nor the National Agencies can be held responsible in case of a conflict."
