#### 1. Aristotle University of Thessaloniki:

Courses at Aristotle University of Thessaloniki are normally taught in Greek. However, there are courses in other languages too, especially at the Foreign Language Faculties, Faculty of Law (courses in English, French and German language), School of Journalism & Mass Communication, and School of Economics. Application/nomination procedure:

- 1. Partner university should nominate students to the Office of International Relations of the University of Ljubljana. The nominations should be sent to <a href="mailto:intern.office@uni-lj.si">intern.office@uni-lj.si</a>
- 2. After partner university nomination exchange students should fill in an <u>online application</u>. There is no need to send a paper copy of the application.
- 3. At the end of the online application students will find the necessary documents to upload to the application: Transcript of Records (of your home university), Learning Agreement and Language Certificate. Student application will be processed after students have followed all the steps of the application system and entered all the required information.
- 4. After the host institution will receive student's application and approval of student's host department has approved your application, we will send you an Acceptance letter and information on living and studying in Ljubljana.

The receiving institution will send its decision within 8 weeks.

3. A Transcript of Records will be issued by the receiving institution no later than 5 weeks after the assessment period has finished at the receiving HEI.

#### 4. Termination of the agreement

In the event of unilateral termination, a notice of at least one academic year should be given. This means that a unilateral decision to discontinue the exchanges notified to the other party by 1 September 20XX will only take effect as of 1 September 20XX+1. The termination clauses must include the following disclaimer: "Neither the European Commission nor the National Agencies can be held responsible in case of a conflict."
