1. Aristotle University of Thessaloniki:

Courses at Aristotle University of Thessaloniki are normally taught in Greek. - Exchange students will meet the admission requirements of the host university in terms of prerequisites for courses and language proficiency.
- Exchange students will be admitted as full time, non-graduating students at the host university.
- The host university will provide an orientation programme for incoming students.
- Exchange students are entitled to the same rights and privileges as students normally enrolled at the host university, except for the right for graduation.
- The host university will comply with all relevant health and safety regulations of the host country for incoming exchange students.
- The home university will inform the host university previous to the exchange about any disabilities to ensure that relevant support can be put in place.

2. Following the receipt of the paper application (printed online application), AUTH will send its decision within 4-6 weeks.
3. A Transcript of Records will be issued by the receiving institution no later than 5 weeks after the assessment period has finished at the receiving HEI.

2. The receiving institution will send its decision on admission within **5** weeks
3. The host university will issue a Transcript of Records no later than **5** weeks after the assessment period has finished.

The host university will report the transcript of records from each visiting student to the home university using the English language.

4. Termination of the agreement

In the event of unilateral termination, a notice of at least one academic year should be given. This

means that a unilateral decision to discontinue the exchanges notified to the other party by 1 September 20XX will only take effect as of 1 September 20XX+1. The termination clauses must include the following disclaimer: "Neither the European Commission nor the National Agencies can be held responsible in case of a conflict."
