#### 1. Aristotle University of Thessaloniki:

Courses at Aristotle University of Thessaloniki are normally taught in Greek. - 3. A Transcript of Records will be issued by the receiving institution no later than 5 weeks after the assessment period has finished at the receiving HEI.

TR TEKIRDA01 will send its decision within 4 weeks after submitting all required documents.

In the end of the semester, exam results and final course grades that belong to Erasmus incoming students are recorded to the University automation system by the academic units; and then Erasmus Office prepare official Erasmus transcript of records including local grades and the ECTS equals according to the data on automation system for each student. Normally, transcripts of records are issued as hard copy before students' departure; but if some of the courses are at that time not recorded in the transcript, the final version will be sent to the student and/or to the home university within 4 weeks from the end of the semester. In this case, student should inform the Faculty International Coordinator about the missing courses and contact information.

#### 4. Termination of the agreement

In the event of unilateral termination, a notice of at least one academic year should be given. This means that a unilateral decision to discontinue the exchanges notified to the other party by 1 September 20XX will only take effect as of 1 September 20XX+1. The termination clauses must include the following disclaimer: "Neither the European Commission nor the National Agencies can be held responsible in case of a conflict."
