Supporting Researchers at Risk

Inspireurope Mapping report

- Shortage of (short/long term) funding for fellowships/ positions
 & competitiveness of research labour market are top 2 challenges
- At EU level, some noteworthy recent policy initiatives framed around defending academic freedom e.g Bonn Declaration on Freedom of Scientific Research (Oct 2020)
- However, no dedicated European level fellowship mechanism exists currently exists
- **3 State-funded national level fellowships** exist in France, Germany and Finland which could provide good practice for other Member States

National-level Actions in Europe



- There is no one-size fits all approach to organising a national-level initiative in support of researchers at risk.
- National-level support for at-risk scholars serves to publicly highlight the crucial role of scholars, free inquiry, and free expression in democratic societies. Public attention to these issues is needed now more than ever.

SAR Greece Section formation history

- 2018: AUTh joined SAR
- Oct. 2018: AUTh hosted the first meeting for Greek universities and national agencies to discuss forming a SAR Greece section.
- Oct. 2020: SAR Europe and AUTh co-hosted a meeting for Greek universities to continue work towards a SAR Greece Section.
- Dec 2020: Ionian University joined the SAR network
- Jan 2021: University of the Aegean joined the SAR network
- Jun 2021: Univ of Thessaly joined the SAR network
- Oct 2021: Launch of SAR Greece Section!
- Dec 2021: Panteion Univ joined the SAR network
- 2022
- University of Crete joined the network
- University of Western Macedonia joined the network
- Hellenic Meditarranean University soon to become a member
- Ongoing discussions with another 9 Greek Universities





SAR Greece Section – How was it established?

- Start from within! Ensure support at the highest University level (Rectors of the joining Universities)
- Presentation/raising awareness at the highest possible level (Rectors' Synod April 2021, Vice-Minister of Education – May 2021) to promote specific measures for the support of researchers at risk (pushing for a special regulatory decision to enable Greek HEIs to offer temporary positions for R@Rs beyond the regular procedures for academic posts)
- Prof. Alexandros Triantafyllidis and Assoc. Prof. Andreas Takis updating HE <u>the President of the Hellenic</u> <u>Republic</u> on SAR Greece and the Inspireurope project (March 14, 2022)
- Personal communications with academics and HEIs' administration at all levels (not just one time but with follow-ups) to develop/expand the network




Dissemination at Greek Level

Call for a Researcher at Risk

- 1. Follow normal regulations of AUTh's Research Committee for scholarship processes
- 2. Call for proposals published with a deadline (nationally and through Euraxess)
- Interdepartmental selection committee for the evaluation of applications
- 3. Open for researchers at risk with a Ph.D. degree
- All subject areas
- - Requirements:
 - 1. confirmed at risk status
 - 2. Letter of intent from academic mentor at AUTh



Definition of at-risk status

- 1. Refugee status in Greece or in another EU member state,
- 2. Subsidiary protection status in Greece or in another EU member state,
- 3. Presentation of an official request for the recognition of the refugee, and recognition as an 'at-risk scholar' by Scholars at Risk (SAR-status)
- 4. Residence in Greece or in another EU member state and identification as 'at-risk scholar' by Scholars at Risk,
- 5. Residence in a non-EU country and identification as 'atrisk scholar' by SAR,
- 6. Currently at risk in home country and already identified/or in the process to be identified as an 'at-risk scholar' by SAR
