National PAUSE program

- Created in 2017
- **200 scientists and artists in exile**
- Work contract of a year (renewable)
- At the Unistra: 29 researchers (2024)
- Countries of origin: Congo: Haiti, Iran, Lybia, Pakistan, Russia, Soudan, Syria, Turkey, Ukraine, Venezuela, Yemen

Combined support by PAUSE and Euraxess

1. PAUSE: contract, acceptance, financing
2. Euraxess: administrative help (housing, social security, residence permit, schooling of children)
3. After end of work contract: support and help offered by Euraxess career program

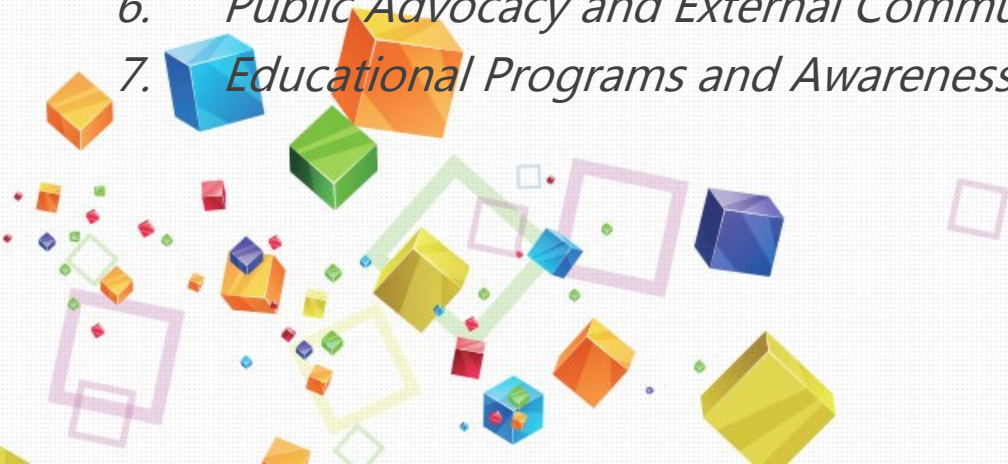

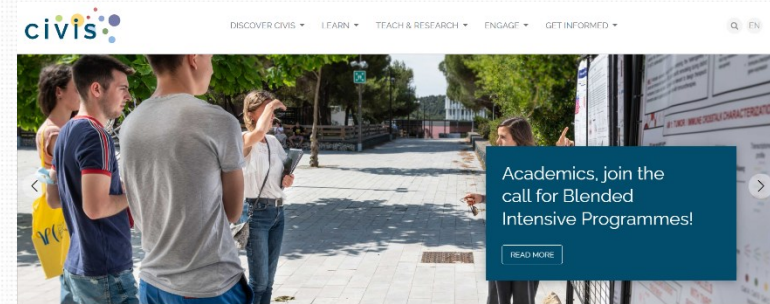

UGOT Institutional Actions to support Academic Freedom

- **Hosting** exiled scholars: The University Board earmarks funding for two scholars/year
- **Coordinating** the Swedish section of the Scholars at risk network since its start in 2015
- **Collaborating** with other stakeholders to act and advocate for Academic Freedom



UGOT Institutional Actions towards Responsible Internationalization

- **Support** such as checklist, discussion guide and material for further reading available via our intranet
- **Trainings and workshops for key staff** categories (i.e. head of faculty, head of department, chief of administration)
- **Annual workshop for students** going abroad: Global horizons - fostering responsible internationalisation
- **Collaboration** with other Swedish stakeholders to raise awareness and create common ground in difficult issues
